Important Battery and WEEE Information

Notice for built-in rechargeable battery

The device is a class II electrical appliance.

Recharge the battery strictly according to instructions included in the product documentation.

Use the power charger provided with the product.

If you do not carry the included charger with your device, you have the option of using a qualified USB-C charger.

It is recommended to use a charger that complies with applicable national/regional regulations for mobile device adapters. Only use a charger that complies with international and regional safety standards (such as EN/IEC/UL 62368-1) for charging. Other chargers may not comply with applicable safety standards, and using such chargers to charge may result in injury or death.

The power delivered by the charger must be between min 10 Watts and max 20 Watts to achieve the maximum charging speed. And the device supports USB Power Delivery (USB-PD).

DANGER

Do not attempt to remove or replace the internal rechargeable lithium-ion battery. To extend battery life, we recommend charging the battery to at least 30% to 50% capacity each time and recharging it every three months to prevent over-discharge.

Don't use your device in temperatures below 0°C or above 40°C. Don't store/transport your device in temperatures below -20°C or above 60°C.
